# Commonwealth of Australia Constitution Act

##### 7 The Senate

The Senate shall be composed of senators for each State, directly chosen by the people of the State, voting, until the Parliament otherwise provides, as one electorate. **NOT BY POLITICAL PARTIES**

#### Part III – The House of Representatives

##### 24 Constitution of House of Representatives

The House of Representatives shall be composed of members directly chosen by the people of the Commonwealth, and the number of such members shall be, as nearly as practicable, twice the number of the senators. **NOT BY POLITICAL PARTIES**

Treasonous Political Parties took control of the Governor-General and Commander-in-Chief Office in 1960. By doing this the Treasonous Political Parties have removed Our Queen, Her Most Excellent Majesty, Royal Assent and the Authority from Our High Court of Australia.

In the year 1965 all State Governors and State Parliaments created Acts with purported Crown Authority for the purported Commonwealth Parliament to create the Dollar. #### Chapter I—The Parliament,

##### Part I—General,

##### Section 3—Salary of Governor-General

3. There shall be payable to the Queen out of the Consolidated Revenue fund of the Commonwealth, for the salary of the Governor-General, an annual sum which, until the Parliament otherwise provides, shall be ten thousand **pounds**.  
The salary of a Governor-General shall not be altered during his continuance in office.
46. Until the Parliament otherwise provides, any person declared by this Constitution to be incapable of sitting as a senator or as a member of the House of Representatives shall, for every day on which he so sits,

be liable to pay the sum of one hundred **pounds** to any person who sues for it in any **court of competent jurisdiction.** Remember this High Court of Australia is compromised. We don't have a Governor-General to become a Governor-General in Council to appoint Judiciary and the Treasonous Judiciary lost the Authority for being the Guardian of the Constitutions.

Section 48—Allowance to members:

48. Until the Parliament otherwise provides, each senator and each member of the House of Representatives shall receive an allowance of four hundred **pounds** a year, to be reckoned from the day on which he takes his seat.

Section 66—Salaries of Ministers

66. There shall be payable to the Queen, out of the Consolidated Revenue Fund of the Commonwealth, for the salaries of the Ministers of State, an annual sum which, until the Parliament otherwise provides, shall not exceed twelve thousand **pounds** a year.

**All to be paid in pounds NOT COUNTERFEIT DOLLARS**  
**All Contracts in Dollars is Fraud. Fraud voids all contracts.**
